Open Space Plan

- List protected lands: conservation, open space, farmland & trails in Marlborough
- Shows developments from last open space plan
- Partly funded by state money so projects are great!

Councilor's Comments City of Marlborough Plans Developments/Construction

- 57 Main Street
- Marlborough Commons upgrades, includes new lighting
- Main Street Crosswalks
- Ames St./Forest Gutierrez Co.-preserving open space
- Greatland crime lab/The Campus Simarano Dr., 300 jobs
- MBTA requirements satisfied by creating zones in existing/ongoing development

Councilor's Comments

Senior Tax Relief Senior Citizen Residential Property Work-off Program (SCRPT)

- Program allows eligible seniors to volunteer their skills/services & in return receive property tax abatement
- Fiscal Year 2026, abatement amount \$1,500 (100 hours @ \$15 per hour
- Applications are typically available @ the Senior Center

Senior Tax Relief

Senior Circuit Breaker Tax Credit (MA State Program)

- State program offers tax credit to eligible seniors based on their property taxes or rent
- Max credit for 2024 was \$2,730
- Eligibility: MA resident 65 or older & meet certain income & property value requirements
